## COMMENTS

There has been an unprecedented decline in crop harvests across all plantations resulting in only 4.4 mkgs being offered by all Brokers for Sale # 34 of August 30 & 31, 2022, for which auction the catalogues closed last Friday. The High, Medium and Low elevations have been subjected to very heavy rainfall throughout July with dull and overcast skies which severely curtailed crop. The weather has since improved with sunny conditions reported, but there is still no "bud-break" to increase yields. The Plantation Industry is however hopeful that crops can be expected to improve from early September.

Meanwhile, Sri Lanka Tea Production of 19.8 mkgs for July, 2022 has just been released, and shows an alarming drop of 6.5 mkgs over the corresponding month last year with marked declines in crop from all three elevations. The current year's January to July Tea Crop amounts to a mere 153 mkgs which is – 35 mkgs over the harvest of 188 mkgs made during the same period last year. More details appear elsewhere in this report.

This week's tea auction (Sale # 32) was conducted on August 16 & 17, 2022 (Tue/Wed), with a weight of 5.1 mkgs, a marginal drop of 0.1 mkgs over the previous sale. The Low Grown Leafy, Semi Leafy, Tippy & Small Leaf/ Premium Flowery catalogues totaled 2.25 mkg, while the Main Sale High & Medium segment had 0.63 mkg. The Ex Estate category had 0.68 mkg.

There was good general demand at easier prices for Ex Estate teas. Best Western BOP's / BOPF's declined Rs. 100/- to 200/ per kg. BOP's in the below-best category eased Rs. 50/- and more, whilst their BOPF's counterparts which commenced substantially easier, were later firm to irregularly lower. At the lower end, both BOP's and BOPF's were Rs. 100/- and more, easier. Nuwara Eliya BOP's were irregular and easier whilst there was a paucity of their corresponding BOPF's offerings. Uda Pussellawa BOP's and BOPF's were irregular and eased Rs. 100/- to 150/-. Seasonal Uva BOP's and BOPF's were irregular following quality. Plainer Uva BOP's were lower up to Rs. 50/- while their BOPF's lost Rs. 100/- to 150/-. <u>CTC Teas</u> – Selected High and Medium Grown PF1's were firm whilst others were much lower. Low Grown PF1's were Rs. 300/- to 500/- easier. The limited availability of High and Medium grown BP1's were dearer up to Rs. 100/- and more while Low Growns were irregular. There good but selective demand from Japan, Germany and other European markets for the best liquoring teas. Buyers for China, Taiwan and Hong Kong were also active. Russian interest was maintained at lower levels.

Good demand was again witnessed for Low Grown teas. Select best OP1's together with improved below-best teas were maintained, while poorer sorts were firm to dearer. Well-made OP's/OPA's were fully firm to dearer while poorer sorts also met with improved enquiry. Select best BOP1's were firm while others ruled barely steady. Well made Pek/Pek1's generally gained on last while lesser sorts appreciated further. Stylish FBOP's / FBOPF1's were firm to selectively dearer, but cleaner below-best teas as well as bottom level teas were mostly dearer. There was good demand from buyers for the Middle Eastern whilst the CIS shippers too were active. Demand from Russia was fully maintained. Turkey and Syria lent active support for the Pekoe grades. Libya continued to actively bid for secondary leafy grades, whilst Iraq concentrated on bottom level teas.

This week's auction comprised of 9,954 lots with a total quantity of 5,137,319 kgs.

## **<u>HIGH GROWNS TEAS</u>**

**BOP** : Best Westerns declined Rs. 100-200 per kg and more for select high priced teas of last week In the Below Best category few select well-made teas were barely steady, whilst the others declined Rs. 50 per kg and more. At the lower end of the market, a few neat leaf coloury sorts declined up to Rs. 100 per kg whilst the others eased further. Nuwara Eliya's were irregular and barely steady. Uda Pussellawa's were irregular and declined up to Rs. 50 per kg. Uva's - Seasonal teas were irregular following quality. Other non-seasonal types - neat leaf coloury sorts were firm, whilst the others were Rs, 20-40 per kg easier.

**BOPF**: Best Western's - A majority of the teas declined Rs. 100-200 per kg. Teas in the Below Best category commenced substantially easier and as the sale progressed were firm and Rs. 50-100 per kg easier. At the lower end, majority of the teas declined Rs. 100-150 per kg. Nuwara Eliya's had hardly any offerings. Uda Pussellawa's were Rs. 100-150 per kg lower. Uva's - Seasonal teas were irregular following quality. Other non-seasonal types - Better sorts declined Rs. 100-150 per kg whilst the poorer types eased further.

**Mediums** – KTDA mediums were irregular at firm to USC10 dearer to USC6 below previous rates and many lines were neglected; plantation mediums were well competed for and appreciated by up to USC32 with selected invoices at USC74 above last prices.

Plainer – Were irregular at steady to USC10 dearer while others lost up to USC14.

**Best** – Steady to USC10 dearer to easier by up to USC22.

**Brighter** – Shed up to USC8.

# LANKA COMMODITY BROKERS LTD SRI LANKA TEA PRODUCTION- JULY, 2022



Sri Lanka has once again recorded a dismal tea crop for the month of July, 2022, of a mere 19.8 Mkgs which reflects a drop of 6.5 Mkgs when compared to the harvest of 26.3 Mkgs in July 2021. During the first 7 months of the current year, the total production of all three elevations amounts to only 153.0 Mkgs which is a decline of 35.0 Mkgs when compared to the corresponding figure of 188.0 Mkgs, recorded in 2021. The year-to-date deficit of 35.0 Mkgs is expected to widen further in view of the poor crop intakes that are being recorded in August as well, and, there is a little doubt therefore, that, Sri Lanka will have one of the lowest recorded Tea Productions at the end of the current year.

# Kenyan tea pickers' court bid against Scottish firm is halted

Case being brought in the Court of Session has temporarily ceased due to action being taken in the Kenyan legal system

James Finlay, the Scottish tea company fighting a multi-million pound class action lawsuit, has won a court order to bring the case to a temporary halt.

The Aberdeen-registered company is being sued for damages by more than 1,000 former and current employees, who claim they suffered musculoskeletal injuries working on its tea farms in Kenya.

Lawyers for the workers said the court order was a "very desperate attempt" after coming together against the company in the Court of Session.

James Finlay lost an appeal against the case being allowed to go ahead and has instead now taken action through the legal system in Kenya.

Following its application, the Employment and Labour Relations Court in Nairobi has issued an interim anti-suit injunction, prohibiting the workers from pressing ahead with the Scottish case for now.

Those bringing the case allege they were required to carry out repetitive manual labour, with long hours and no breaks in Kenya's Kericho region.

Their lawyers had expected many more former tea pickers to join the lawsuit over the coming months, but that process has been stopped under the injunction.

In court papers, James Finlay argued that the Court of Session case represents an "an assault on the sovereignty of the Republic of Kenya" and violates the country's constitution.

It described the Scottish lawsuit as "vexatious, oppressive, unjust, unconscionable and costly to defend" and said it will cause the company "irreparable damage and harm".

It contends that the "proper and natural forum" for a work injury dispute involving Kenyan workers governed by Kenyan law is in Kenya, not Scotland.

Another hearing involving lawyers from both sides is scheduled to take place in the Nairobi court later this month.

The tea pickers' legal team, led by Thompsons Solicitors, is expected to challenge the order, having previously argued that as a Scottish company, James Finlay is open to legal action in Scotland's courts.

The wider Finlays group is one of the world's biggest tea producers, with customers including Starbucks. It dates back to a Scottish textile merchant, who founded the business in 1750.

# An auction in Kolkata sells Assam Orthodox tea for Rs 22K per

kilogram Aug 11, 2022 | Poonam Nath.

**Digital Desk:** The Mokalbari Tea Estate in eastern Assam produced a batch of Assam Orthodox specialty tea that was sold for Rs 22,000 per kg on Wednesday at the auctions in Kolkata.

The tea was purchased by Kolkata-based Bhansali and Company for its Russian buyer, Masterskaya of Tea, according to representatives of the Mokalbari Tea Estate.

The tea achieved the highest price to date in the Kolkata auction market.

Anish Bhansali, the director of Bhansali and Company, said: "We have a large global customer base that is interested in such specialized tea. One of the leading Assamese Orthodox producers, Mokalbari, rarely offers such specialized tea for auction. Our customer is overjoyed to be able to buy the tea. "

Ajay Jalan, the director of Mokalbari Tea Estate, claims that they often ship such expensive specialty tea directly to Europe and infrequently sell through the auction market.

"These treats are created by hand using a unique tea varietal. We are pleased with the positive response from the customers and plan to continue providing these specialties in the future," said Jalan.

With three tea estates covering 800 hectares of land and employing 1,600 skilled workers, the Mokalbari Group produces two million kg of both CTC and Orthodox forms of tea each year.

There are about 850 large tea estates in Assam, which produces about 55% of all the tea in India. In addition, thousands of small tea gardens are privately held.
